4. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

5. The program(s) have been granted provisional accreditation. Coimbatore Institute of Technology, Civil Aerodrome Post, Coimbatore-641014, Tamil Nadu should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifiers before sending the Compliance report for granting further Accreditation.
6. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Coimbatore Institute of Technology, Civil Aerodrome Post, Coimbatore-641014, Tamil Nadu as a whole. **As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
7. The accreditation status of the above programmes is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programme as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
