



move OC-30 Pinch Technology under the category 'Energy-nano Technology Courses (Group-IV)'.

- Minutes of the meeting of the Board of Studies in Civil Engineering held on Saturday, the 8<sup>th</sup> May, 2021 at 10.00 A.M at Coimbatore Institute of Technology, Coimbatore - 641014 to review the syllabus of B.E Civil Engineering, B.E Part time-Civil Engineering and PG Civil Engineering Programs.
- Dr.V.G.Srisanthi, HOD, Civil Engineering Department welcomed the members and initiated the discussions by requesting the external members Dr.R.Thenmozhi, Dr.S.T.Ramesh, Dr.S.Thirugnanasambandam, Er.S. Sivalingam and Er.ArunPrasath to review the syllabus for both UG and PG courses as per agenda and to suggest changes/modifications if any.
- Dr.V.G.Srisanthi first presented vision and mission of the Department of Civil Engineering with Programme Educational Objectives (PEO), Programme Outcomes (PO) and Programme Specific Outcomes of UG course. PO, PEO and PSO were refined based on discussion in Department meetings, Programme Advisory Committee meetings, stakeholders meetings and based on AICTE Curriculum. Later, the overview of approved curriculum in the previous meeting was presented first. The board then discussed in length the newly added professional electives and their syllabus and suggested various additions and alterations in the proposed syllabus.


1. Parasuram Balasubramian recommended to include the following courses if it has not been included.


